-Framed artwork can be no larger than 40''x 40''

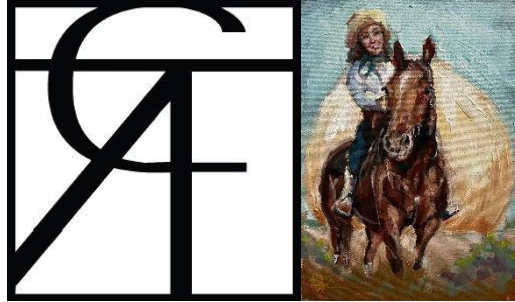
-Artwork must be properly framed/wired; no saw-tooth hangers
