Third Place: \$75


ELIGIBILITY AND CONDITIONS:

- -Original work only; no reproductions
- -Framed artwork can be no larger than 40"x40"
- -Artwork must be properly framed/wired; no saw-tooth hangers
- -Artwork must be family friendly (no graphic violence or nudity) and subject to CTFAC Board discretion.
- -Entries must be accompanied by completed Release Form and Artwork Tag information form. Please also include an Artist Bio/Statement.

SALES: A Commission of 20% paid to CTFAC is charged on any artwork sales. Any artwork sold must remain in Gallery until the end of the Show on Thursday, October 31. Purchaser must make arrangements for any mailed artwork.


